Statement of intent

Holywell School is committed to ensuring equal opportunities for all students, regardless of financial circumstances, and has established the following policy and procedures to ensure that no child is discriminated against by our offering of school trips, activities and educational extras.

In addition, we are committed to adhering to legal requirements regarding charging for school activities, and meeting all statutory guidance provided by the Department for Education (DfE).

1. Legal framework

- 1.1. This policy will have consideration for, and be compliant with, the following legislation and statutory guidance:
 - Education Act 1996
 - Children Act 1989
 - The Charges for Music Tuition (England) Regulations 2007
 - The Education (Prescribed Public Examinations) (England) Regulations 2010
 - Freedom of Information Act 2000
 - DfE (2018) 'Charging for School Activities'
 - DfE (2017) 'Governance Handbook'
 - Our Funding Agreement
 - ESFA 'Academy trust handbook'

Charging for education

- 1.2. We will not charge parents for:
 - Admission applications
 - Education provided during school hours
 - Education provided outside school hours if it is part of the national curriculum, part of a syllabus for a prescribed public examination that the student is being prepared for by the school, or part of religious education
 - Instrumental or vocal tuition, unless provided at the request of the student's parents
 - Entry for a prescribed public examination, if the student has been prepared for it at the school
 - Examination re-sits, if the student is being prepared for the re-sits at the school.
- 1.3. We may charge parents for the following:
 - Materials, books, instruments or equipment, where they desire their child to own them
 - Optional extras
 - Music and vocational tuition (in certain circumstances)
 - Use of community facilities
 - Admin charge of 2.5% (minimum £1) to cover cost of administration of trips, including transaction fees.
- 2.3 We will inform parents on low incomes and in receipt of relevant benefits of the support available to them when asking for contributions.

2. Optional extras

2.1. We may charge parents for the following optional extras:

Education provided outside of school time that is not:

- Part of the national curriculum
- Part of a syllabus for a prescribed public examination that the student is being prepared for at the school
- Religious education
- Examination entry fees where the student has not been prepared for the examinations at the school
- Transport, other than that arranged by the Local Authority (LA) for the student to be provided with education
- Board and lodging for a student on a residential visit
- Extended day services offered to students (for example Breakfast Club, After School Clubs, and supervised homework sessions).
- 2.2. When calculating the cost of optional extras, the school will only take into account the following:
 - Materials, books, instruments or equipment provided in relation to the optional extra
 - The cost of buildings and accommodation
 - The employment of non-teaching staff
 - The cost of teaching staff (including teaching assistants) under contracts for services purely to provide an optional extra
 - The cost, or an appropriate proportion of the costs, for teaching staff employed to provide vocal tuition or tuition in playing a musical instrument.
- 2.3. The school will not charge in excess of the actual cost of providing the optional extra divided by the number of participating students. We will not charge a subsidy for any students wishing to participate but whose parents are unwilling or unable to pay the full charge. If a proportion of the activity takes place during school hours, we will not charge for the cost of alternative provision for those not participating.
- 2.4. Participation in any optional activity will be on the basis of parental choice and a willingness to meet the charges. Therefore, parental agreement is a prerequisite for the provision of an optional extra.

3. Examination fees

- 3.1. We may charge for examination fees if:
 - The examination is on the prescribed list (which includes SATs, GCSEs and A levels), but the student was not prepared for it at the school
 - The examination is not on the prescribed list, but the school arranged for the student to take it

 A student fails, without good reason, to complete the requirements of any public examination where the governing board or LA originally paid or agreed to pay the fee.

4. Examination re-sits

- 4.1. Where a student is entered for a second or subsequent attempt at an examination, we will pay the fee. Once students have left the school, re-sits must be taken at the school.
- 4.2. If a student or their parents consider it to be in the best interests of the student to request that an examination is re-marked, any fees involved must be covered by the student or their parents. If the awarding body changes the overall grade of the result, the school will not be charged by the awarding body and the parent/student will have their fees refunded.

5. Voluntary contributions

- 5.1. We may, from time-to-time, ask for voluntary contributions towards the benefit of the school or school activities. If an activity cannot be funded without voluntary contributions, we will make this clear to parents at the outset. We will also make it clear that there is no obligation for parents to make a contribution, and notify parents whether assistance is available.
- 5.2. No child will be excluded from an activity simply because their parents are unwilling or unable to pay. If a parent is unwilling or unable to pay, their child will still be given an equal opportunity to take part in the activity. If insufficient voluntary contributions are raised to fund an activity, and the school cannot fund it via another source, the activity will be cancelled.
- 5.3. We will strive to ensure that parents do not feel pressurised into making voluntary contributions.

6. Music tuition

- 6.1. Instrumental and Vocal Music tuition is the only exception to the rule that all education provided during school hours must be free. The Charges for Music Tuition (England) Regulations 2007 allow for charges to be made for vocal or instrumental tuition provided either individually or to groups of any size provided that the tuition is at the request of the student's parents.
- 6.2. The charges will not exceed the cost of the provision, including the cost of the staff providing the tuition.

6.3. No charge will be made in respect of a student who is looked after by a local authority (within the meaning of section 22(1) of the Children Act 1989).

7. Transport

- 7.1. We will not charge for:
 - Transporting registered students to or from the school premises, where the LA
 has a statutory obligation to provide the transport.
 - Transporting registered students to other premises where the governing board or LA has arranged for students to be educated.
 - Transporting students to meet an examination requirement when they have been prepared for the examination at the school.
 - Transport provided for an educational visit.

8. Residential visits

- 8.1. We will not charge for:
 - Education provided on any visit that takes place during school hours.
 - Education provided on any visit that takes place outside school hours if it is part of the national curriculum, part of a syllabus for a prescribed public examination that the student is being prepared for at the school, or part of religious education.
 - Supply teachers to cover for teachers accompanying students on visits.
- 8.2. We may charge for board and lodging but the charge will not exceed the actual cost.
- 8.3. If parents are in receipt of one or more of the following benefits, they <u>maywill</u> be exempt from board and lodging costs and, in such cases, the remission of charges for board and lodging payments will be met by the school. These costs will be borne by our contingency funds. The eligible benefits are:
 - Income Support
 - Income-based Jobseeker's Allowance
 - Income-related Employment and Support Allowance
 - Support under part VI of the Immigration and Asylum Act 1999
 - The guaranteed element of State Pension Credit
 - Child Tax Credit, provided that they are not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190
 - Working Tax Credit run-on paid for four weeks after they stop qualifying for Working Tax Credit
 - Universal Credit if they apply on or after 1 April 2018, their household income must be less than £7,400 a year (after tax and not including any benefits they receive.)

9. Education partly during school hours

- 9.1. If 50 percent or more of the time spent on an activity occurs during school hours (including time spent travelling if the travel occurs during school hours), it is deemed to take place during school hours and no charge will be made.
- 9.2. If less than 50 percent of the time spent on an activity occurs during school hours, it is deemed to have taken place outside school hours and we may charge for the activity; however, we will not charge if the activity is part of the national curriculum, part of a syllabus for a prescribed public examination that the student is being prepared for at the school, or part of religious education.
- 9.3. **Residential visits:** If the number of school sessions covered by the visit is equal to or greater than 50 percent of the number of half days (any period of 12 hours ending with noon or midnight on any day) spent on the visit, we will not charge for the activity.
- 9.4. Any charges for extended day services will be optional.

10. Damaged or lost items

10.1. The school may charge parents for the cost of replacing items broken, damaged or lost due to their child's behaviour. Parents will not be taken to court for failure to pay such costs.

11. Remissions

- 11.1. We have set aside a small fund to enable families in financial difficulty to send their children on visits/activities. The funding is limited and there is no guarantee that all requests can be met. Please make your enquiry to Mrs Sarah King, our Office Manager, in the first instance. Assistance will be allocated on a needs basis, and if the full cost of the trip/activity cannot be met through assistance funding and voluntary contributions, the trip/activity may be cancelled.
- 11.2. Parents in receipt of any of the following benefits may request assistance with the costs of activities:
 - Income Support
 - Income-based Jobseeker's Allowance
 - Income-related Employment and Support Allowance
 - Support under part VI of the Immigration and Asylum Act 1999
 - The guaranteed element of State Pension Credit
 - Child Tax Credit, provided that they are not also entitled to Working Tax Credit and they have an annual gross income of no more than £16,190

- Working Tax Credit run on paid for four weeks after they stop qualifying for Working Tax Credit
- Universal Credit.
- 11.3. To request assistance, parents should contact the Office Manager, Mrs Sarah King in the school office.

12. Monitoring and review

12.1. This policy will be reviewed annually.
