

# HOLYWELL ACADEMY FULL GOVERNING BOARD STRUCTURE AND MEMBERSHIP – Update: October 2025

## Holywell Church of England Academy

*This text has advisory status and should be read alongside the 2012 Academy Articles and the list of Full Governing Board Members and Directors whose format was restructured in May 2019.*

1. **Signatories to Articles:** The first page of the Articles confirms the signatories as the three Corporate Member representatives who are:
  - Representative of the Diocese of St Albans Educational Trust
  - Representative of Cranfield PCC
  - Representative of Wootton PCC
2. **Other Members:** The Chair of Governors (CoG) is an ex officio Member.
3. **Directors (not Trustees):** In a church school setting 'Directors' are the equivalent to 'Governors' in a maintained school. The term 'Trustees' in a church school academy setting has a different, very specific meaning relating to the site ownership.
4. **Members and Directors distinction:** Since Holywell's existing academy articles were written, nationally a new set of Model Articles for church schools has been issued. In this more recent model there is a strong emphasis on separation of powers (ie. individuals not having dual roles as both Members/Directors) and a marked preference for five Members where possible. The Education and Skills Funding Agency (ESFA) echoes both these points in the Academies Financial Handbook (Sept 2020).
5. **Role of the two PCCs and appointment of foundation directors:** For Holywell Academy, as with any academy, Directors (Academy Governors) are appointed by the Members. The Members for Holywell Academy comprise three Corporate Members (The Diocese of St Albans Educational Trust, Cranfield PCC, and Wootton PCC) alongside the CoG as an ex officio Member. Each PCC appoints a 'Corporate Member representative' and it is these individuals who, together with the other Members, formally appoint Directors. Each PCC's formal involvement in appointing Directors is through its Corporate Member representative who will carry out that task on their behalf. Informally, the PCC's collective advice as part of the overall Director recruitment process is also warmly welcomed and encouraged. PCCs will often have a good idea of possible candidates for Director roles and their interest and informal input is a valuable part of the process.

The Academy Articles for Holywell could be written more clearly in respect of the foundation Directors; the only reference is a brief footnote on page 20. As a former VA school, Holywell's foundation Directors should always be in a majority of two. In practice the two PCCs between them rightly ensure that their respective appointments collectively form that overall majority of two; so that whilst the

wording of the Articles lacks clarity, local practice in this respect is good and appropriate.

6. **Cranfield parish's involvement:** The incumbent of Cranfield parish is an ex officio Director on the Full Governing Board, as per article 50. At May 2019, the present incumbent was also Cranfield PCC's chosen Corporate Member representative hence had a dual role on the Full Governing Board. In December 2020 a new incumbent was appointed to the parish who will also be the Cranfield PCC's Corporate Member representative and hence continue to have a dual role on the Full Governing Board.
7. **Wootton parish's involvement:** The incumbent of Wootton parish is not an ex officio Director, and at May 2019 was not occupying the role of the PCC's Corporate Member representative. At May 2019, Wootton PCC's Corporate Member representative was an appointed PCC Director, and this individual thus also had a dual role on the Full Governing Board. Since November 2020, the incumbent of Wootton parish has taken on the role of Corporate Member representative for the Wootton PCC instead of the Director referred to above. This goes some way to address the points made in item 4 above regarding the need for separation between Members and Directors.
8. **Appointment of new Members:** Members appoint any additional non-corporate Members – this requires the agreement of Members locally plus the written consent of the Board of Education.
9. **Appointment of new Directors:** This needs Member agreement including formal approval of the Diocese of St Albans Educational Trust (DSAET) as one of the Corporate Members. This does not apply to Parent Governors who are appointed by the parents through an election process, as per articles 53-58. With regard to the appointment of Staff Governors, article 50A states that 'the Members may appoint up to three Staff Governors through such process as they may determine'. This is currently done by direct Member appointment but it is up to the Members to decide which method of appointment to use. The option of an elected process is open to Members if they wish to do this.
10. **Appointment of any Associate roles:** This is for the full governing board to decide locally. These are reviewed and appointed annually at the first Full Governing Body meeting of the academic year. Anyone in an Associate role is appointed to bring specific skills/insights. These roles do not have Director/Governor status nor do they have voting entitlement at Full Governing Board meetings, nor should they be counted in the quorum for the meeting.
11. **Quorum:** This is inconsistently given as two or three within the Articles. I suggest that two is probably an error and that in practice a quorum should be three to enable a majority vote should that be needed.
12. **Role of Members with regard to the annual accounts:** Members should attend an AGM each year and formally receive the accounts. This includes the DSAET who, as a Corporate Member, must be invited to the AGM. It is the Directors' role to prepare the annual report and accounts with their accountants and formally approve their

acceptance as a true record for the financial year, before they are received by the Members at the AGM.

**13. Number of Directors required by the Articles:** Articles 46a and 50 require a minimum of 11 'governors' of whom the incumbent is one. In the table above, the incumbent used to be included as a 'CPCC governor' but is now referred to as a 'governor'. We have chosen to refer to 10 'Foundation Governors' who are split equally between the 2 PCCs. Item 5 above makes the point that the Articles are not clear in this regard, and it is this lack of clarity and subsequent clarification, which has led to the change in the way the incumbent is now listed and our own interpretation on the PCC Governors. The other requirements are for up to 3 Staff Governors (46b), 3 Parent Governors (46d) and the Headteacher as an ex-officio Governor (46e). There is also provision for up to 2 co-opted governors (59).

**14. Number of Directors being large:** The Full Governing Board is unusually large. If recruitment challenges make this unsustainable in future, as long as the foundation majority of 2 is maintained, overall numbers could be reduced within the parameters of the Articles (for instance by a reduction in numbers of Parent Governors and/or co-opted governors). This is something for the Full Governing Board to monitor over time.

- The Chairperson of the Governors
- Additional members as agreed by the members in consultation with the Diocesan Board of Education

The Directors (Governors) of the Academy Trust: subject to Articles 48-49 and 64, the Academy Trust shall have the following appointed by the Members:

- Not less than 11 Directors (Governors) appointed under Article 50
- Up to three staff Directors (Governors), appointed under Article 50A
- 3 Parent Directors (Governors), appointed under Articles 53-58
- The Principal
- Any Additional Directors (Governors) appointed under Article 62, 62A Or 68A
- Any Co-opted Directors (Governors)
